# Part-time Academic Hourly Clinical Counselor Counseling Center

## **Primary Position Function/Summary:**

The hourly clinical counselor will primarily provide clinical assessment, counseling, and triage for individual clients.

## Major Duties and Responsibilities:

Primarily will provide clinical assessments and counseling for individuals and couples; in addition may provide group counseling; emergency triage services as needed. The clinical counselor at times may provide clinical supervision of practicum students and other new staff (when appropriate depending on need); participate in treatment teams, liaison groups, and outreach activities (as needed).

### **Education and Licensure:**

Masters in Social Work or Counseling, Doctorate in Clinical or Counseling Psychology, or related field required. Appropriate professional licensure (or license eligibility) in Illinois required. The following licenses (or licensed eligibility) are accepted clinical psychologist (LCP), clinical social worker (LCSW), clinical professional counselor (LCPC), or marriage & family therapist (LMFT)

#### **Experience:**

Demonstrated ability to conduct clinical interviews, including clinical assessment, case conceptualization, and treatment plan formulation for students with a broad spectrum of psychological problems, ranging from adjustment issues to major psychiatric disorders; demonstrated interest, expertise, and experience in assessing and treating acute clinical presentations; and demonstrated ability to develop and foster relationships with key stakeholders is required.

#### **Compensation**:

Pay rate competitive to rates within the central Illinois community and commensurate with experience. This position offers no benefits. You will be able to use the mass transit system and university libraries.

## Length of Job:

Generally, this position will be within the academic calendar schedule to provide adequate continuity. This position may last for a longer period of time by mutual consent of the incumbent and the Center. This position will be reviewed with option to renew contract on an annual basis. The work hours will vary depending on need and candidate availability. Weekly schedule may range from 8 hours up to 35 hours weekly as negotiated. The Counseling Center hours are 8a.m. to 5p.m., Monday through Friday.
